To assist both the wedding party and the Savannah Makeup team, we have put together a list of helpful suggestions that will make your experience with us run more smoothly. Please contact us with any questions prior to receiving services.

- 1. PLEASE LET US KNOW THE EXACT TIME THAT EVERYONE IN YOUR BRIDAL PARTY NEEDS TO BE COMPLETELY DONE BY. THIS TIME IS IMPARITIVE IN OUR SCHEDULING PROCESS. Based on this time, we will determine the time that our team needs to start the hair and makeup process. This time is based on years of experience; unforeseen circumstances can and do often arise and it is better to have more time than to run out of time. Our number one goal is having our Bride be stress-free and at ease during this process!
- 2. Once we have set a specific start time for your services, we ask that you please not arrive late. Late arrival times interfere with our goal to have everyone ready on time. Additionally, you may also be subject to a Late Arrival Fee. If you feel that there may be issues with the designated start time, please contact us as soon as possible.
- 3. Savannah weather is extremely humid. Because of this, we recommend wearing your hair up during the ceremony. Please discuss your hair options with the stylist. Please have your hair completely dry prior to services. **There will be an additional \$25 charge to dry wet hair.** If your hair is not naturally oily, please try not to wash it 24 hours prior to services. Additionally, please try to apply a small amount of mouse or gel to your hair.
- 4. Beginning two days prior to your makeup services, please exfoliate on both days and hydrate your skin. Aloe is the preferred product for hydration.
- 5. Please bring any pictures you have of hair and makeup styles that you like with you to your trial or day-of services. Please try to have in mind a style for both hair and makeup that you like.
- 6. It is the responsibility of the Bride to communicate all of this information to the wedding party. Things will always run more smoothly if everyone is on the same page and aware of all of this information beforehand.
